2. The agenda of the meeting was to open (Technical) bids of the firms as per Tender Notice **(Annex-B)**.

**Discussion / Decisions**

3. In response to Tender Notice dated 08-03-2023, respectively three (03) representatives of different bidders as per **(Annex-C)** attended the bid opening (Technical) dated 24-03-2023. All bids were opened in the presence of representatives of the bidders. The Committee informed the bidders that all bids will be evaluated as per the bid evaluation criteria.

4. **Stage 1- Preliminary Evaluation:**

The committee evaluated all three (03) bidders based on the Preliminary Evaluation criteria given in the tender documents. M/s Techaccess Pakistan Pvt Ltd. and M/s Data Hawk Enterprises SMC-Pvt Ltd. qualified **(Annex-D)** in the preliminary evaluation, whereas M/s Rewterz Information Security is declared disqualified due to non-compliant with Clause No.1 i.e., "Bidder is a registered/incorporated company in Pakistan with SECP at least for the last 03 years for Lot# 3 & 5" of the Preliminary Evaluation criteria mentioned in the tender document.

5. **Stage II- Technical Evaluation:**

Both preliminary qualified firms were evaluated technically **(Annex-E)** based on the Technical Evaluation Criteria given in the tender document. Both the bidders were declared
